DIVORCE

MORAL SUPPORT IS KEY...

A divorce is typically a crisis event in a person's life, requiring the support of many people. HOW LONG...

To obtain a divorce in Arizona, one or both of the parties must have maintained a domicile in Arizona for at least 90 days prior to the filing of a Petition for Dissolution. Depending on the issues involved, your case could be resolved in as few as three months, or it could take much longer. A contested divorce will generally take a minimum of six to nine months; however it could extend to well over a year. When contemplating a divorce, one should carefully consider the time and expense involved and plan accordingly.



DOMESTIC VIOLENCE

Unfortunately, family law cases often involve allegations of domestic violence.
